

- d. Copyright and Similar Rights means copyright and/or similar rights closely related to copyright including, without limitation, performance, broadcast, sound recording, and Sui Generis Database Rights, without regard to how the rights are labeled or categorized. - a. License grant.

    - A. reproduce and Share the Licensed Material, in whole or in part, for NonCommercial purposes only; and
    - B. produce, reproduce, and Share Adapted Material for NonCommercial purposes only.
  - 2. <u>Exceptions and Limitations</u>. For the avoidance of doubt, where Exceptions and Limitations apply to Your use, this Public License does not apply, and You do not need to comply with its terms and conditions.
  - 3. Term. The term of this Public License is specified in Section 6(a).
  - 4. Media and formats; technical modifications allowed. The Licensor authorizes You to

exercise the Licensed Rights in all media and formats whether now known or hereafter created, and to make technical modifications necessary to do so. The Licensor waives and/or agrees not to assert any right or authority to forbid You from making technical modifications necessary to exercise the Licensed Rights, including technical modifications necessary to circumvent Effective Technological Measures. For purposes of this Public License, simply making modifications authorized by this Section 2(a)(4) never produces Adapted Material.

- 5. Downstream recipients.
  - A. <u>Offer from the Licensor Licensed Material</u>. Every recipient of the Licensed Material automatically receives an offer from the Licensor to exercise the Licensed Rights under the terms and conditions of this Public License.
  - B. <u>Additional offer from the Licensor Adapted Material</u>. Every recipient of Adapted Material from You automatically receives an offer from the Licensor to exercise the Licensed Rights in the Adapted Material under the conditions of the Adapter's License You apply.
  - C. <u>No downstream restrictions</u>. You may not offer or impose any additional or different terms or conditions on, or apply any Effective Technological Measures to, the Licensed Material if doing so restricts exercise of the Licensed Rights by any recipient of the Licensed Material.
- 6. <u>No endorsement</u>. Nothing in this Public License constitutes or may be construed as permission to assert or imply that You are, or that Your use of the Licensed Material is, connected with, or sponsored, endorsed, or granted official status by, the Licensor or others designated to receive attribution as provided in Section <u>3(a)(1)(A)(i)</u>.

### b. Other rights.

- 1. #### Section 3 – License Conditions.

Your exercise of the Licensed Rights is expressly made subject to the following conditions.

#### a. Attribution.

    - v. a URI or hyperlink to the Licensed Material to the extent reasonably practicable;
    - B. indicate if You modified the Licensed Material and retain an indication of any previous modifications; and
  - C. indicate the Licensed Material is licensed under this Public License, and include the text of, or the URI or hyperlink to, this Public License.
- You may satisfy the conditions in Section <u>3(a)(1)</u> in any reasonable manner based on the medium, means, and context in which You Share the Licensed Material. 3. If requested by the Licensor, You must remove any of the information required by Section 3(a)(1)(A) to the extent reasonably practicable.

### b. ShareAlike.

#### Section 6 – Term and Termination.

- b. To the extent possible, if any provision of this Public License is deemed unenforceable, it shall be automatically reformed to the minimum extent necessary to make it enforceable. - c. No term or condition of this Public License will be waived and no failure to comply consented to unless expressly agreed to by the Licensor.
- d. Nothing in this Public License constitutes or may be interpreted as a limitation upon, or waiver of, any privileges and immunities that apply to the Licensor or You, including from the legal processes of any jurisdiction or authority.
