

Article charge

New Journal of Physics (NJP) is completely free to read and is funded solely by article publication charges. The full-rate article charge for 2015 is £1300 (EUR1560, US\$2080) (excluding VAT where applicable). We send invoices for payment after articles are accepted for publication and you should send your payment to IOP Publishing Ltd.

Discounts are available as follows:

- Members of the Institute of Physics and Deutsche Physikalische Gesellschaft receive a 25% discount (applicable only once per article).
- Members of NJP Associate Members (http://iopscience.iop.org/1367-2630 /page/Associate%20members) receive a 5% discount (applicable only once per article).
- NJP referees can qualify for a 10% discount for each article that they referee for the journal. The qualifying criteria for referees to be eligible for this discount can be found in the referee guidelines. (http://iopscience.iop.org/1367-2630/page/Referee%20guidelines)
- The Max Planck Society (http://www.mpg.de/en) will pay the article charge centrally for all articles where the corresponding or last author is affiliated to a Max Planck institute.
- Goettingen University Library will pay the article charge centrally for all articles where the corresponding author is affiliated to Goettingen University. - Through the support of the Abdus Salam International Centre for Theoretical Physics (http://www.ictp.it/) (ICTP) we are pleased to be able to waive the article charge for authors based in countries (http://data.worldbank.org/about/country-classifications/country-and-lending-groups#IDA) that have been identified by The World Bank for support as part of their International Development Association (IDA).
- The Chinese Academy of Sciences (http://english.cas.cn/) (CAS) will cover 50% of the article charge for all articles where the first or corresponding author is affiliated to any one of the CAS member institutes. (http://english.cas.cn/CASI/)
- Through its participation in the SCOAP³ (http://scoap3.org/) agreement, *New Journal of Physics* is able to offer authors of qualifying high-energy physics articles the chance to publish on an open access basis without paying any fee, with effect from 1 January 2014. The article publishing charges (APCs) will be paid by CERN on behalf of the SCOAP³ consortium. To qualify, article preprints must be deposited in one of the hep-ex, hep-lat, hep-ph or hep-th primary categories of arXiv.org and authors must indicate that their article qualifies for SCOAP³ funding during the regular article submission process.
- This journal is included in the Austrian open access pilot (http://ioppublishing.org/newsDetails /Austria-open-access). This means that authors funded by the Austrian Science Fund (FWF) should qualify to publish on an open access basis and have their article publication charge paid by the FWF. Find out more here.
